#### Ahmedabad, Chennai and Jaipur are the new kids on the block




# **Key Features of the Startup Oasis Startup Incubation Model**

## **Progress on Action Plan**

#### Labour Laws

- No requirement for registration if number of employees is less than 20
- Self certification facility active for compliance of labor laws at https://www.ldms.rajasthan.gov.in/
- Scheme is valid for 5 years, provided entrepreneur files returns annually
- Facility of filing single online return also provided on the portal
- Not more than 20% of the units covered under the scheme are picked up for inspection
- Once inspected, startups will not be inspected for another three years, if no complaints are received.
- In case of complaint, unit would be inspected only with the authorization issued by the Labor Commissioner

#### Environmental Laws

White category industries are exempt from consent / authorisation

## **Future Plans Including Reforms**

### Rajasthan Startup Policy 2015

- 5 Year term
- Budget allocation Rs 54.25 Cr
- Key Targets and Objectives
  - > 50 Incubator / Incubator-like support organizations to be established
  - ➤ Atleast 500 startups to be supported and incubated.
  - > 100,000 sq ft of Incubation Space to be developed / facilitated.
  - ➤ Angel and Early Stage Capital of Rs 500 Cr to be mobilized for startups.
